Proposed Action Title: Direct Final Rule (DFR) and accompanying Notice of Proposed Rulemaking (NPR) for amended energy conservation standards for residential dishwashers

Proposed Action Description:

In this Direct Final Rule, DOE proposes amended energy conservation standards for residential dishwashers. The proposed amended standards are the maximum allowable estimated annual energy use (EAEU) and the maximum allowable water consumption. These proposed standards, if adopted, would apply to all products listed in Table I.1 of the NPR and manufactured in, or imported into, the United States on or after January 1, 2013.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.
