Proposed Action or Project Descriptio

American Recovery and Reinvestment Act:

The Washoe Tribe of Nevada and California proposes to 1) perform an energy audit to assess the efficiency of existing Tribally-owned administrative, commercial, and residential buildings and education outreach and 2) conduct Tribal administrative, commercial, and community building retrofits on identified buildings which includes the following: lighting retrofits, insulation installation, programmable thermostats, replacement of doors and windows, weatherstripping/caulking, and replacement of appliances.

Conditions: Replacing doors and windows on buildings older than 50 years of age require consultation with the THPO/SHPO

Categorical Exclusion(s) Applied: A9, B2.5, B5.1

This action would not: threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, including DOE and/or Executive Orders; require siting, construction, or major expansion of waste storage, disposal, recovery, or treatment facilities, but may include such categorically excluded facilities; disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that pre-exist in the environment such that there would be uncontrolled or unpermitted releases; or adversely affect environmentally sensitive resources (including but not limited to those listed in paragraph B.(4)) of Appendix B to Subpart D of 10 CFR 1021). Furthermore, there are no extraordinary circumstances related to this action that may affect the significance of the environmental effects of the action; this action is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.
