Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Hire consultant to train staff on sustainable practices, 2) residential energy equipment upgrades (wood stove changeouts and weatherization), 3) infrastructure upgrades in community facilities (lighting, heating systems, windows, etc.), 4) replace HVAC system at Fire Headquarters and Station One facilities, 5) participate in Tacoma Alliance for Clean Technology, 6) participate in BEST Program, 7) Downtown Transportation Partnership to reduce trips to city center, 8) replace traffic signals and warning beacons with LEDs, 9) painting and signage for bike-lane and minor construction activities including traffic signal improvements, sidewalk/curb construction, limited paving and patching, and installing speed bumps, signage, and pedestrian-activated flashing beacons.

Conditions: Historic preservation clause applies to this application
