Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Commercial energy audit program; 2) commercial (business owner) energy retrofit program; 3) energy efficiency retrofits in city facilities to include: window refurbishment in City Hall Annex; install new static controller in Island Grove Events Center; replace Island Grove direct-fire gas heating system with boiler; replace City Hall Annex boiler; replace Transit Bus Garage boilers with infrared heaters; replace boiler at Downtown Recreation Center; replace roof-top HVAC unit in Rodarte Center; replace lights in Greeley History Museum; replace lobby lights and theater lights in Union Colony Civic Center; install motion sensors in Recreation Center; install motion/audio sensors in Civic Center; exterior lighting at Greeley Museum; and lighting retrofits at Recreation Center; and 4) conduct energy audits of city facilities.

Conditions: Historic preservation clause applies to this application (Greeley Historic Museum [1929])
