Proposed Action or Project Descriptio American Recovery and Reinvestment Act:

The Mashantucket Pequot Tribe of Connecticut proposes to 1) conduct weatherization activities of approximately 40 homes including installing foam insulation; caulking/sealing doors and windows; replacing windows, sinks, and showers; weatherizing attic hatches, chases, basements, vents/hoses, trim, garage doors, sliders, decks/breezeways, knee walls, closets, gaps, and registers for baseboard heating; and 2) retrofit energy efficient light fixtures and bulbs in the Public Safety Building and the Community Center Building.
