Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Retrofit HVAC at City Hall and install energy management controls and programmable thermostats in several locations and replace existing lighting fixtures, primarily interior lighting, with more energy efficiency bulbs and ballasts and occupancy sensors; 2) hire consultant to conduct a transportation/optimization study for the bus transit system; and 3) conduct audits of streetlights, variable frequency drives, heat pumps, etc., and retrofit streetlights within city.

Conditions: None--Programmatic Agreement covers activities associated with facilities >50 yrs
