1) Reimbursement for the cost of preparing the energy efficiency and conservation strategy, 2) public education/outreach campaign, 3) purchase hybrid vehicles and install charging stations, 4) energy efficiency window retrofits at City Hall and the Police Station, 5) fund program to increase cycling and walking opportunities in the city including safety training and bicycle rodeo, 6) technical services to assist with building energy audits, and 7) replace high pressure sodium lighting with light-emitting diode lights in parking garage.
