Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Acquisition of services to support development of an energy efficiency and conservation strategy and a comprehensive strategic energy plan (ongoing); 2) hire coordinator to run marketing campaign for community-based outreach program; partner with community organizations to encourage energy efficiency home improvements and market residential weatherization initiatives from community groups; 3) creation of a municipal energy office; 4) conduct feasibility studies for installation of solar photovoltaic systems (ACTIVITY 4 EXCLUDES INSTALLATION FROM NEPA APPROVAL); 5) initiation and implementation of a comprehensive energy conservation and efficiency strategy for city-owned buildings including benchmarking, and acquisition of a contractor to execute an energy savings performance contract for a number of city-owned buildings and participation in the utility efficiency programs and hire electricians to install electric charging stations; and 6) retrofit specified municipal buildings to improve energy efficiency including installation of hot water circulation pumps, exhaust fan controls, air handling unit controls, unit ventilators and zone controllers, and lighting upgrades.

Conditions: In accordance with Programmatic Agreement—note: excludes installation of solar photovoltaic in Activity 4

Categorical Exclusion(s) Applied: A1, A9, A11,B2.5, B3.6, B5.1

Furthermore, there are no extraordinary circumstances related to this action that may affect the significance of the environmental effects of the action; this action is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.
