1) Implementation of energy efficiency and conservation strategy, 2) energy efficiency retrofit of building to include insulation, window replacement, energy efficient HVAC, lighting and controls, 3) hire consultant to promote energy efficiency renewables and recycling and hire energy manager, 4) expansion of advanced traffic control system for synchronization of traffic signals, 5) adoption of codes/ordinances for green building and sustainable development, 6) purchase recycling bins, and 7) install traffic signal and install solar street lights at the Adams Shore Library.
