Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Develop an energy efficiency and conservation strategy (completed); 2) acquire technical services to develop an ongoing energy efficiency and management program; 3) perform energy efficiency retrofits to city-owned buildings which includes cool-roof installation, HVAC replacements, revolving door installations, adding insulation, lighting upgrades (fixtures, motion sensors, and task lights) to identified buildings (City Hall, Kiwanis Recreation Center, G.B. Myers Recreation Center, Fire Station #2, City Building, Traffic Signal Shop, Arts Council Building, Smith Recreation Center, College Lakes Recreation Center, Westover Recreation Center, Cliffdale Recreation Center, Environmental Services Building, Building Maintenance Offices and Shop, and Alexander Street Complex); 4) install traffic light controller and camera at several intersections; 5) replace 24 high pressure streetlights with energy efficient LED fixtures; and 6) install multilayer optical film on windows at Fayetteville Regional Airport.
