American Recovery and Reinvestment Act:

1) Installation of a solar photovoltaic system with a capacity of approximately 117 KW on the roof of the Public Works Garage (1978), 2) acquisition of services to develop an energy efficiency and conservation strategy (completed), 3) replace windows in the Municipal Building, 4) upgrade HVAC systems in the Municipal Building, 5) upgrade lighting and install occupancy sensors in the Municipal Building, 6) lighting upgrades and install occupancy sensors in the Health Department Building, 7) install monitoring system for the Public Works solar photovoltaic system, 8) replace wooden exterior doors with energy efficient doors on the Municipal Building, 9) add insulation to the Municipal Building, 10) install window solar shades on the Municipal Building, and 11) conduct energy audits of Hamilton Township buildings.
