American Recovery and Reinvestment Act:

1) Develop McKinley County energy efficiency and conservation strategic plan; 2) hire grant consultant to oversee procurement, reporting, and other requirements to support proper grant management and direct the energy sustainability programs; 3) conduct residential and commercial building audits and perform a baseline energy audit of all facilities in the county; and 4) retrofit lighting system including removal and disposal of existing lighting lamps, ballasts, and tombstones and installation of new lamps, ballasts, and tombstones in the McKinley County Adult Detection Center (15 years old).
