Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Development of a residential energy efficiency retrofit program including development of workflow software, marketing, training, and purchase of equipment for measurement and verification of effectiveness of retrofits; 2) provision of services to commercial business (e.g., development of financial models) to support energy efficiency improvements and collaboration with GreenCom (e.g., tenant/landlord agreements) to create innovative mechanisms for funding energy efficiency improvements; 3) provision of a loan loss reserve for solar thermal installations and energy efficiency retrofits; and 4) financial incentive programs for the Long Island Green Homes (LIGH) rebate program including a) provide rebates to homeowners on energy efficiency retrofit work facilitated by the LIGH Program, b) provide incentives to homeowners participating in the LIGH program that generate new leads that become building retrofits in the LIGH program, and c) provide incentives to homeowners that participate in a study of the effectiveness and performance of the LIGH program.
