Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Create energy efficiency and conservation strategy, 2) hire consultant to implement energy efficiency and conservation block grant activities, 3) establish revolving loan fund for businesses and residences to conduct energy efficient upgrades, 4) retrofit pump at water treatment plant, 5) retrofit windows and build vestibule at City Hall and replace overhead garage doors at Fire Station #1, 6) Energy Efficiency Fair and light bulb giveaway, and 7) technical consultant services to assist with creation of green code amendments to the City's general development code.

Conditions: Historic preservation clause applies to this application (City Hall [1952] and Fire Station #1 [1926])
