Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Hire an energy efficiency inspector; 2) conduct residential and municipal building energy audits; 3) energy efficiency lighting retrofits (replace fluorescent fixtures and motion sensors) at the Municipal Building Garage (1940s); 4) grant administration; 5) roof and HVAC replacement at the former Hamilton Municipal Building (historic Frederick G. Mueller Building); 6) replace windows, insulate overhead, and replace doors at the Municipal Garage (1940s); 7) replace HVAC system at the Municipal Garage; 8) install motion sensors in the Municipal Garage (1940s); and 9) replace high pressure sodium lights on Brookwood Avenue with light emitting diode light fixtures.

Conditions: Historic preservation clause applies to this application
