Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Compensation to the city for grant implementation, 2) technical consultant to write the energy efficiency and conservation strategy, 3) energy efficiency retrofits at City Hall IT Department, 4) lighting retrofits at the wastewater treatment plant, 5) HVAC retrofits at Berea Road office, 6) boiler replacement, HVAC retrofits, and lighting upgrades at the Beck Center for the Arts, 7) hire consultant to monitor street light electrical usage, 8) retrofit 18 traffic control loops, 9) retrofitting outdoor pedestrian lighting with LEDs, and 10) replace aeration blowers with smaller variable speed aeration blowers at the wastewater treatment plant.

Conditions: Historic preservation clause applies to this application (Beck Center [1920's era], City Hall [1958], Fire Station #2 [1918], and Refuse Office Building [1930])

Categorical Exclusion(s) Applied: A9, A11, B2.5, B5.1
