Proposed Action or Project Descriptio

American Recovery and Reinvestment Act:

The Comanche Nation of Oklahoma proposes to conduct the following activities utilizing EECBG funding: 1) hire a technical consultant to develop a greenhouse gas emissions inventory for tribal buildings and facilities; 2) conduct a wind power feasibility study for tribal buildings at the Comanche Nation Tribal Complex including obtaining wind measurement equipment and erecting and operating the measurement equipment, assessing the wind data, and preparing summary reports; 3) install wind turbines (approximately 20 kW) on tribal buildings built between 1980 and 2010; 4) replace single-pane windows in two Comanche Nation Tribal Complex Buildings with new energy efficient windows; and 5) retrofit windows; heating, ventilation, and air conditioning systems; and furnace at the Tribal Administration Building.
