Proposed Action or Project Description: American Recovery and Reinvestment Act:

1) Conduct energy audit and development of an energy efficiency and conservation strategy (completed), 2) retrofit street lighting on State Street with more energy efficient lighting, 3) retrofit the Municipal Building with a more energy efficient boiler, chiller and coils, 4) retrofit the Streets Garage roof with a more energy efficiency membrane and insulation, 5) retrofit the Central Fire Station Engine #3 with more energy efficient furnaces, 6) retrofit the South Central Fire Station Engine #12 with a more energy efficient boiler, 7) retrofit Fire Station Engine #11 with a more energy efficient boiler, 8) replace windows at Fire Station Engine #12, 9) replace doors at Fire Station Engine #12, 10) replace steam coil heaters at Municipal Building, 11) replace air conditioning units at Municipal Building, 12) replace air conditioning units at Fire Station Engine #12, 13) replace uninterruptable power supply at Municipal Building.

Conditions: Historic preservation clause applies to this application (Fire Station Engine #11 [1951])

Categorical Exclusion(s) Applied: A9, A11, B1.32, B2.5, B5.1
