American Recovery and Reinvestment Act:

1) Develop energy efficiency and conservation strategy and hire technical consultant to develop Master Sustainability Plan; 2) energy efficiency building retrofits to identified city buildings including boiler, chiller and HVAC replacements and improvements and installation of new controls; interior/exterior lighting upgrade/replacement; parking ramp improvements; destratification fan installations; and window/door replacements; 3) traffic and street light replacement to LED; and 4) technical consultant services to develop a feasibility study for renewable energy projects.
