American Recovery and Reinvestment Act:

1) Lighting controls at Community Activity Center, 2) retrofit activated sludge treatment units air handlers and controls at wastewater treatment plant, 3) retrofit air cooler with a new air-cooled condenser unit and install lighting controls at the Police and Municipal Court Building, 4) energy efficiency upgrades at Town Hall Center including HVAC and lighting controls and attic insulation, 5) install virtual dedicated server, and 6) install foil radiant barrier in the attic of the Animal Adoption Center.
