American Recovery and Reinvestment Act:

1) Develop energy efficiency and conservation strategy, 2) funding for home energy improvement program, 3) energy efficiency retrofits (remote sports field lighting controls; energy management control systems; upgrade exterior and interior lighting, programmable thermostats, motion sensors, and high efficiency water heaters; upgrades and retrofits including lighting, gas, and mechanical systems) at several identified city facilities, 4) educational program on energy efficiency for city residents, 5) replace vehicles w/ alternative fuel vehicles, and 6) traffic signal lighting retrofits and automated controls update.

Conditions: Historic preservation clause applies to this application (Museum [1890-1900] and Parks Building [1928])
