CAAFDP Objectives

- Increase the number of alt fuel vehicles & hybrids (~599 vehicles)
 - 355 gasoline hybrids
 - 231 CNG vehicles
 - 11 HD Diesel Hybrids
 - 2 HD PHEV Diesels
- Develop fueling & charging infrastructure to support growth of alternative fuel use (~131 Stations)
 - 9 public access CNG & LPG locations
 - 8 shared access CNG stations
 - 10 shared access E-85 locations
 - 104 (46 public access) charging stations
- Combined Benefits of the Project
 - 448 metric tons/yr in reduced criteria pollutants
 - 7,647 metric tons/yr in reduced CO₂ (eq. to removing1390 cars/yr)
 - 3.1 Million gallons of petroleum/yr displaced
 - 77 full time equivalent jobs

Summary

The CAAFPD Clean Cities Project Will:

- Increase the number of alternative fuel vehicles & hybrids
 (~599 vehicles)
