
Q: What do I need to do at Grants.gov?

Applicants only need to do one action at grants.gov: download the “application package”. You can find it there by clicking on “Apply for Grants”, then clicking on “download a grant application package” - use CFDA number 81.128. You will need to have the proper version of Adobe. Once you download the application package, save it on your computer.

**This is the only action you need to do in grants.gov.
No grants.gov registration is required.**





Q: What documents should be in my application?

 - SF424 Application for Federal Assistance
 - Project/Performance Site Location Form
 - Project Activity File noting an activity under Activity Area 1 (Development of the EECS)
 - Financial Management Assessment
 - Assurances: ARRA 2009 (Davis-Bacon) and Authorized Applicant Assurance (Resolution for Tribal Applicants)
 - SF-LLL (if applicable)

Q: I'm ready to submit my EECS now, but I'd like to review some samples first.

Q: What documents do I submit with my application if my EECS is ready?

- **If you ARE submitting an EECS with your initial application, your application should contain the following documents:**
 - SF424 Application for Federal Assistance
 - Project/Performance Site Location Form
 - Project Activity Files – 1 per activity
 - SF 424A Budget Information
 - Budget Justification File
 - Subaward Budget File
 - Financial Management Assessment
 - EECS (on either Attachment D or Attachment E)
 - Assurances: ARRA 2009 (Davis-Bacon) and Authorized Applicant Assurance (Resolution for Tribal Applicants)
 - SF-LLL (if applicable)
 - NEPA Forms (if applicable)

Q: What goes in the Budget Justification File?

- **The Budget Justification File must contain the supporting documentation for the proposed costs. Costs can be based on competitive quotes or bids, catalogue pricing, published labor rates or actual labor rates. Examples are as follows:**
 - “\$50,000 in equipment costs is for 5 widgets at a cost of \$10,000/widget. This cost is based on a quote from Widgets-R-Us”
 - “\$500 in labor costs consists of a surveyor working an estimated 25 hours at \$20/hour”
 - “\$1,000 in consultant costs: 10 hours x \$100/hour utilizing “most favored customer” rate”

Q: How do I submit my application?
